Library System: Met Monday, April 15th

- Internet filter has reached its useful life; replacement is being priced.
- Testing Program Administration software is being tested for registration and payment
- New office headquarters Bent Creek is in construction and will be complete by mid-May

Affordable Housing & Trust Fund Board: Met Tuesday, April 9th

- Seven families purchased their first home this year.
- To date 714 families have purchased their first home.
- There is an article in the sentinel and on WITF Smart Talk regarding the homebuyers program. Four families who were awarded funding; however, they cannot find an affordable home to purchase their funding will expire.
- Tim Whelan and Kirk Stoner participated in the WITF Smart Talk and discussed the need for more housing options for residents. A solution will be necessary, such as zoning changes to permit higher density residential development.

Capital Region Council of Governments: Met Monday, April 15th

- Guest speaker was Representative Andrew Lewis from Dauphin County. The State House has passed a package of workforce development bills, and now at the Senate. These are also a priority of Governor Wolf's budget.
- The Surplus Equipment Auction is in its final planning, scheduled for July 3rd
- There are discussions of a model ordinance design for wireless towers
- A storm water round table is scheduled at South Middleton Township building regarding MOU's with Conservation Districts.

- Received the dashboard and will provide to the Board.

Recycling & Waste Authority: Met Monday, April 15th

• There was discussion regarding Waste Management Inc. planning to acquire Advanced Disposal. This may cause issues with contracts.

- The County is required to have a Waste Management Plan. Staff has begun the process to update the Plan.
- Household Hazardous Waste Program is a new process this year with online sign-up and a fee based program.
- Electronic Recycling first quarter 72,274 pounds, Year to Date: 710,339 pounds, 7,629 transactions, average charge is \$46.50.

Commissioner Hertzler questioned that residents may not want to sign-up online and will show up the day of an event to dispose of their household hazardous waste. Commissioner Eichelberger stated that it was discussed at the Authority meeting. There have been no issues so far with sign-up and staff does have a plan if someone shows up on the day of a collection event with no pre sign-up.

- 2019 Spring Event Sandwich Generation review 40 people attended
- Fall Event Impact of the opioid crisis, grandparents caring for grandchildren, family members caring for family members

- Opportunity for a Scholarship Award to support education to attend a conference, camp or a course
 in the STEM or other area of interest. Approximate amount of the award would be \$500.00.
